ACTORSITE.COM IS PROHIBITED BY LAW FROM OFFERING OR ATTEMPTING TO OBTAIN AUDITIONS OR EMPLOYMENT FOR YOU. IT MAY ONLY PROVIDE YOU WITH TRAINING.

YOUR RIGHT TO CANCEL

You may cancel this contract and obtain a full refund, without any penalty or obligation, if notice of cancellation is given, in writing, within 10 business days from the initial date of payment under the contract.

For purposes of this section, business days are Monday through Friday.

To cancel this contract, email a dated copy of the following cancellation notice or any other written notice of cancellation to ACTORSITE.COM at actorsite.support@gmail.com.

NOT LATER THAN MIDNIGHT OF THE 10th DAY. YOU MUST SEND FROM THE SAME EMAIL ADDRESS AS THAT FROM WHICH PAYMENT WAS MADE OR WHICH WAS GIVEN AS YOUR EMAIL ADDRESS AT THE TIME OF PAYMENT.

CANCELLATION NOTICE

I hereby cancel this contract.

If you cancel, the fees, minus fees for any services already rendered, which will include any classes which occurred during the 10 day grace period, charged at the full rate of \$60 per class, must be refunded to you within 10 business days after delivery of the cancellation notice to actorsite.support@gmail.com.
